For the purposes of this subrule, "pattern" means two or more times within a 30-day period.</p> <p><b>DESCRIPTION:</b></p> <p>Based on interview and record review, the facility failed to report to the Iowa Department of Inspections and Appeals when a client has committed a pattern of acts on another resident that resulted in physical injury within a 30 day period. This pertained to 1 of 2 clients (Client #4) living in House B. Finding follows:</p> <p>Record review on 7/18/16 identified Client #3's Incident Report dated <b>5/11/16</b>. The report indicated (Client #4) got up from the chair, ran over to the couch, and bit (Client #3) on the left shoulder.
