A facility shall inform all persons prior to employment regarding the performance of the record checks and shall obtain, from the persons, a signed acknowledgment of the receipt of the information. A facility shall include the following inquiry in an application for employment.

Conducting a background check.</i> The facility may access the single contact repository (SING) to perform the required background check.
