Findings are as follows: The facility reported on 12/27/16 Resident #1 eloped from the facility on 12/22/16. The resident was found three blocks away and returned by the police. The resident reported wanting to go for a walk but could not recall how to return to the facility. Resident #1 had no prior history of leaving the facility.
