The sample consisted of 5 personnel files reviewed and the facility reported a census of 50 residents.</p> <p>Findings included:</p> <p>A personnel record for Staff A identified a date of hire as 5/1/17. On 3/23/17, the facility obtained a Single Contact and Background Check (SING) for criminal history and dependent adult abuse, which cleared Staff A, Registered Nurse, to work in the nursing home. A payroll time sheet dated 5/1/17, identified Staff A's first day of employment as 5/1/17. The employment of Staff A did not begin within 30 days of the valid abuse/criminal background check results per 50.7(4). A facility Abuse Prevention, Training and Investigations policy, with a review date of 8/25/16, included direction for a SING background check to be completed no more than 30 days before the start of employment On 7/11/17 at 1:50 P.M., the facility Administrator was interviewed and confirmed the background checks and abuse history checks should be completed within 30 days of hire.</p> <p><b>FACILITY RESPONSE</b></p>
