Wound care; (I, II)</p> <p>DESCRIPTION:</p> <p>Based on observation, record review and staff interviews, the facility failed to to prevent the development of an avoidable pressure ulcer which required wound care for one of nine active resident's reviewed (Resident # 5). The facility reported a census of forty residents.</p> <p>Findings include:</p> <p>1. According to a Diagnosis Description form, dated 6/29/2010, Resident # 5 had the following diagnosis: a late effect fracture, of the C-6 vertebrae, with a spinal cord injury due to a Motor Vehicle Accident in 2002, paraplegia, history of post operative cardiovascular accident (stroke) With right hemiplegia (paralysis) and depression.</p> <p>An admission Minimum Data Set (MDS) assessment, with an assessment reference date of 7/6/20010 revealed Resident # 5 had an admission date of 6/29/2010. The MDS revealed the resident had no difficulty with memory or decision making, required the assistance of two staff with bed mobility, required total dependence on staff for transfer and the resident had not walked during the seven (7) day assessment period. The MDS further documented an assessment of the resident's skin revealed no pressure ulcers (any lesion caused by pressure resulting in damage of underlying tissue). The MDS identified the definition of the different stages of pressure ulcers as the following:</p> <p>Stage 1- A persistent area of skin redness (without a breakdown in the skin) that does not disappear when pressure is relieved.</p> <p>Stage 2 - A partial thickness loss of skin layers that presents clinically as an abrasion, blister or shallow crater.</p> <p>Stage 3 - A full thickness of skin is lost...</p> <p>Stage 4 - A full thickness of skin and subcutaneous tissue is lost...</p> <p>Review of the Facility Pressure Ulcer Practice Guidelines revealed the following:</p> <ul style="list-style-type: none"> a. Prevention strategies will be developed and implemented at the time of the initial admission assessment based upon causative factors which contribute to the resident's risk for skin breakdown. b. The same facility Pressure Ulcer Practice Guidelines described an avoidable pressure ulcer as: Avoidable means that the resident developed a pressure ulcer and the center did not do one or more of the following: Define and implement interventions that are consistent with resident needs. <p>Review of the resident's record revealed no initial nursing care plan had been completed at the time of the resident's admission to the facility. 	<p>interventions had been developed or implemented to prevent the resident's risk for skin breakdown until a comprehensive care plan had been developed on 7/14/2010 (15 days after admission).</p> <p>On 9/23/2010 at 7:59 a.m., Staff N was interviewed and confirmed no initial nursing care plan had been completed.</p> <p>Review of a facility Care Plan policy reflected an initial/temporary care plan would be developed upon admission as soon as a problem was identified.</p> <p>Review of a Comprehensive Care Plan, dated 7/14/2010 indicated the resident had a potential for impaired skin integrity related to paraplegia, right sided hemiplegia, no weight bearing and the need for extensive assistance with bed mobility. The care plan directed staff to float the heels off the bed in order to avoid pressure on the heels whenever necessary (PRN). The care plan included instructions for staff to float (such as placing a pillow under the ankles to "float" the heels off the bed in order to avoid pressure on the heels) the resident's heels whenever necessary (PRN).</p> <p>Review of a facsimile to a Physician on 7/23/2010 indicated the staff had identified a 2.5 by 3.5 cm. (centimeter) blister on the left heel. The nurse documented the resident's heels would be floated in bed. Further review of the resident's Comprehensive Care Plan revealed a new intervention had been added to the care plan on 7/23/2010 (after the development of a stage 2 pressure ulcer) and instructed staff to float the resident's heels when in bed as opposed to floating the resident's heels PRN.</p> <p>Review of the Care Plan Approach records for Resident #</p>

The skin was intact with, no drainage and 100% eschar (black crust),</p> <p>On 7/24/2010, the wound measured 3.2 cm by 4.5 cm. The skin was intact with no drainage and 100% eschar;</p> <p>On 7/30/2010 the wound measured 3.5 cm by 4.5 cm. The skin was intact with no drainage and 100% eschar present;</p> <p>On 7/31/2010 the wound measured 3.8 cm by 5 cm. The resident reported discomfort.</p> <p>On 8/28/2010 the wound measured 3 cm by 4.5 cm and the skin intact, minimum drainage with 100% eschar present. The resident expressed discomfort.</p> <p>On 8/29/2010 the wound measured the same as 8/28/2010 and the resident continued to express discomfort.</p> <p>Further review of the resident's Wound Flow Sheets revealed daily assessments of the left pressure ulcer continued. An assessment, dated 9/20/2010 (59 days after identified) revealed the size of the pressure ulcer had been 3 cm by 3.5 cm, skin intact, no drainage, 5 % eschar and had not yet resolved.</p> <p>Observation on 9/22/2010 at 6:49 a.m., revealed Staff E and Staff Q had repositioned Resident # 5 in bed to his/her right side position. A pillow had been placed under the resident's left leg and the left heel had been floated. The resident's right foot laid directly on the bed and the right heel had not been floated.</p> <p>Observation on 9/23/2010 at 1:27 p.m. revealed Resident # 5 laid in bed on his/her back. Staff C (the acting Director of Nursing-DON) removed a blanket that had covered the resident's legs and feet. Further observation revealed the resident had worn a heel protector on his/her left heel. The resident had a pillow under his/her calves but had not had enough cushion in the pillow to float the resident's right heel. The resident's right heel laid directly on the bed.</p>
